

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000 from Open Space Bond Fund 79104, to supplement the \$700,000 previously authorized by Resolution No. 275892, adopted June 12, 1990, for the acquisition of open space parcel LPCP North #7 for Penasquitos Canyon Preserve, is hereby authorized and approved.
