RESOLUTION NUMBER R- 278902

ADOPTED ON OCT 28 1991

WHEREAS, during the period November 1 through December 1, 1991, various events are scheduled which focus attention on HIV infection and AIDS; and

WHEREAS, the week of November 3, 1991 is AIDS AWARENESS WEEK which addresses education, prevention and service issues of concern to the entire San Diego community; and

WHEREAS, AIDS WALK San Diego will be held on November 17, 1991, during which people will come together for a 10K walk and post walk party to raise fund for HIV/AIDS service providers so that they may meet the growing needs of all those impacted by HIV infection; and

WHEREAS, WORLD AIDS DAY will be observed around the globe on December 1, 1991 to commemorate those who have died as a result of complications due to AIDS, raise awareness of HIV infection and the means of preventing its spread, support individuals and organizations in addressing the social service and medical needs triggered by HIV infection; and encourage ongoing research in finding a vaccine and cure; and

WHEREAS, The City of San Diego has expressed its commitment to and concern with HIV infection issues through: passage of an AIDS legislative policy and an AIDS Anti-discrimination ordinance, annual funding for AIDS service providers, the provision of housing through the San Diego Housing Commission, participation in the purchase and renovation of a building for


the Center for Social Services and involvement in community educational events; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims November 1, 1991 through December 1, 1991 to be "AIDS/HIV MONTH" in San Diego.

BE IT FURTHER RESOLVED, that the Council also commends the many citizens and organizations giving of their time, resources and hearts in the struggle to address the many ramifications of HIV infection and dedicates itself to meeting the future challenges of the epidemic and invites continued community compassion for those living with HIV and their loved ones.
