

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to modify the FY92 C.I.P. #22-084.0 - MISSION BAY TREE PLANTING; and he is hereby authorized to transfer \$45,000.00 from Sludge Mitigation Fund #10507 to C.I.P. #22-084.0, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice

from the administering department, to transfer excess budgeted funds, if any, to Sludge Mitigation Fund #10507.


