BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEISMIC RETROFITTING TO UNIVERSITY AVENUE BRIDGE OVER WASHINGTON STREET in accordance with the specifications.

BE IT FURTHER RESOLVED that the expenditure of an additional amount, not to exceed \$45,300.00, from CIP 53-037.0, Capital Outlay Fund 30245, EARTHQUAKE RESTRAINERS FOR BRIDGES, to supplement funds previously authorized for construction costs, is hereby authorized for the purpose of executing this contract and related costs.


