WHEREAS, the expenditure of \$74,359 from PSD Fund No. 11730 will permit the entire \$330,000 grant to be used on two other under-funded park projects, namely Sunnyslope Neighborhood Park and Southcrest Community Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$74,359 from PSD Fund No. 11730, is hereby authorized, solely and exclusively to supplement the financing authorized by Resolution No. R-278131, adopted on June 24, 1991, for the construction of Nestor Neighborhood Park.
