BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 3, dated October 14, 1991, heretofore filed with the City Clerk of said City as Document No. RR- 278922, issued in connection with the contract between The City of San Diego and Sim J. Harris Company, said contract having been filed in the office of the City Clerk as Document No. RR-276174, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$359,746.70.

BE IT FURTHER RESOLVED that the City Auditor is hereby authorized to transfer \$156,478 from CIP 58-004, Annual Allocation - Miscellaneous Requirements - City Streets, Fund No. 30300 and \$127,024 from Fund 30245 to CIP 52-377.0, solely and exclusively for the purpose of funding this change order.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$283,502 from CIP 52-377.00 is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of Change Order No. 3 and related costs.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to proceed with a City-initiated Cost Recovery District pursuant to Section 62.0208 of the Municipal Code.


