1. DAVIS TAYLOR JETT CO. for Section A, for a total estimated cost of \$167,455.25; terms net 30 days, plus sales tax, with option period increases not to exceed, respectively, 8, 10, 12 and 14% of prices in effect at the end of prior contract period.
2. WESTBURNE SUPPLY for Sections B, C, D, E and F, for a total estimated cost of \$147,332.77; terms 3% 20 days, plus sales tax.
