WHEREAS, the handheld Laser Speed Detection Systems LTI 20-20 is capable of positive vehicle identification, not detectable by radar detectors and used by more than one hundred (100) agencies in the country as a speed enforcement tool; and

WHEREAS, Government Employees Insurance Company (GEICO), consistent with its goal of reducing traffic accidents and fatalities, is willing to donate and the San Diego Police Department desires to accept, two (2) Speed Detection systems for use in speed enforcement; and

WHEREAS, the San Diego Police Department will transfer the speed detection systems to officers assigned to the traffic division which is chiefly responsible for "radar" speed enforcement; and

WHEREAS, the donation is valued at approximately two thousand dollars (\$2,000.00); NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be, and he is hereby authorized to accept a donation of two (2) handheld Laser Speed Detection Systems LTI 20-20 valued at approximately two thousand dollars (\$2,000.00) from Government Employees Insurance Company (GEICO) for use by the San Diego Police Department as speed enforcement tools.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Council, for and on behalf of the City, publicly expresses the gratitude of the citizens of San Diego for this act

of civic generosity.
