WHEREAS, the Police Department of The City of San Diego desires to accept and execute a grant award of two hundred fifty-seven thousand, nine hundred ninety-five dollars (\$257,995.00) as its share of the countywide total of one million, seven hundred thirty-eight thousand, seven hundred twenty-four dollars (\$1,738,724.00) in Anti-Drug Abuse block grant funds for the ongoing program entitled "Jurisdictions Unified for Drug Gang Enforcement" (JUDGE) from the Office of Criminal Justice Planning; and

WHEREAS, the District Attorney's Office of the County of San Diego, as the designated lead agency in compliance with the allocation plan implemented by the Office of Criminal Justice Planning, has completed and submitted the program proposal for Fiscal Year 1991-92; and

WHEREAS, the Office of Criminal Justice Planning has approved the program proposal as submitted by the District Attorney's Office; and

WHEREAS, the grant award will fund the following San Diego Police Department personnel: One (1) police lieutenant, one (1) police sergeant, and two (2) detectives; and

WHEREAS, the program consists of North County and San Diego teams representing a cooperative alliance between nine (9) local law enforcement agencies to continue the successful JUDGE Program

targeting habitual drug and drug/gang offenders; and

WHEREAS, there is no requirement for matching funds and no additional officers will be required to implement the program,
NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, the City Manager be, and is hereby, authorized to accept the Grant Award, as described in the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk, as Document No. RL- 278933, to the Office for Criminal Justice Planning, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof;

BE IT FURTHER RESOLVED AND AGREED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the Office for Criminal Justice Planning and the State of California disclaim responsibility for any such liability;

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
