ADOPTED ON NOV 04 1991

A RESOLUTION OF THE CITY OF SAN DIEGO
ACCEPTING THE URBAN FORM ACTION PLAN.

WHEREAS, on June 10, 1991 the Transportation & Land Use Committee directed staff to organize a three day public workshop to seek revalidation of the City's vision of its desired urban form and formulate comprehensive strategies to implement public policy goals; and

WHEREAS, the Transportation & Land Use Committee directed staff to coordinate the efforts of private sector urban form projects currently in progress, and existing, related City work programs; and

WHEREAS, the Transportation & Land Use Committee directed staff to involve a broad spectrum of community leaders, private citizens, and an interdisciplinary staff team; and

WHEREAS, the Planning Department staff organized a Steering Committee comprised of the City Manager, two Deputy City Managers, the Acting Planning Director, several Department Directors, and key staff from the Departments of Planning, Engineering and Development, Park and Recreation, and Property; and

WHEREAS, a Citizens Advisory Team was formed consisting of leaders from key interest groups including: American Institute of Architects, American Planning Association, American Society of Landscape Architects, Building Industry Association, Citizens

Coordinate for Century III, Coalition for San Diego, Construction Industry Federation, San Diegans, Inc., San Diego Association of Governments, San Diego Association of Realtors, San Diego Chamber of Commerce, San Diego Economic Development Corporation, San Diego Taxpayers Association, and the Sierra Club; and

WHEREAS, the Steering Committee and the Citizens Advisory Team met throughout the summer months to organize the three day workshop, and to prepare a briefing book; and

WHEREAS, Partners for Livable Places agreed to facilitate the workshop with various urban planning experts from around the United States and locally to participate and to lead the discussion; and


WHEREAS, on November 1st and 2nd the workshop was held with San Diego citizens, where key issues and alternative solutions were discussed on such topic areas as sensitive resources, neighborhood character, transportation systems, public facilities, regional planning, economic development and social resources; and

WHEREAS, on November 3rd,, the facilitators, key citizens, and City staff met to synthesize the issues and evaluate integrated solutions as presented the previous two days by San Diego citizens; and

WHEREAS, the workshop concluded with citizen consensus on a vision and a direction The City of San Diego should take in regard to Urban Form by formulating THE URBAN FORM ACTION PLAN;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the Council hereby accepts the URBAN FORM ACTION REPORT and
directs City staff to prepare an evaluation, and if appropriate,
an implementation program to be presented to the City Council by
January, 1992. The City Council will then use this
implementation program to help formulate the Fiscal Year 1992-
1993 budget.
