
ADOPTED ON NOV 12 1991

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of CARMEL MOUNTAIN RANCH, a California partnership, executed in favor of The City of San Diego, bearing date of September 18, 1991, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 278948, granting to said City easements for public street purposes in portions of Lots 1 through 141 inclusive, and 144 through 192 inclusive, 194 through 199 inclusive, "A," "B" and "D" of Carmel Mountain Ranch Unit No. 22A, Map No. 12258, Lots 1, 2, and 6 through 49 inclusive, and 52 through 181 inclusive, of Carmel Mountain Ranch 22B, Map No. 12652, together with portions of Parcels 1 and 2 of Parcel Map No. 16467, 1 through 4 of Parcel Map No. 16496, and 1 and 2 of Parcel Map No. 16494, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named CHALON LANE, COLDWATER COURT, ESPRIT AVENUE, ESSENCE ROAD, ETUDE ROAD, LINDAMERE LANE, MULHOLLAND COURT, SCARSDALE WAY and TRADITION STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him

under seal, to be recorded in the office of the County Recorder  
at no fee for the benefit of the City, with no documentary tax  
due.
