WHEREAS, the applicant will enter into an agreement with the State of California for the subject project; and

WHEREAS, no City funds are available for maintenance of trees provided through this grant, maintenance will be provided through citizens and business people in the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager or his representative be and is hereby authorized to submit an application to secure funding as described in the Council docket supporting information.

2. That the Council hereby certifies that it understands the assurances and certification in the application form.


3. That the Council certifies that it has reviewed and understands the General Provision contained in the state/local agreement shown in the Procedural Guide.
