
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Soon Woo Lee, et al, Partnership, for construction and reimbursement of PVC sewer main and manholes in Menlo Avenue and vicinity, under the terms and conditions set forth in the Participation Agreement on file in the office of the City Clerk as Document No. RR-278956, as well as any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$119,235.00 from Sewer Revenue Fund No. 41506, CIP No. 44-001.0, Annual Allocation for Sewer Main Replacements, is hereby authorized, solely and exclusively for the purpose of providing funds for this project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
