WHEREAS, in response to the rising rate of crime and the alarming increases in violent crime and murder, the City

Manager's office and Police Department have devised a program to combat the City's rising crime rate; and

WHEREAS, a component of the program, the funding of additional patrol officers on an overtime basis to work in various crime infested areas of the City has a cost of \$1 million; and

WHEREAS, in order to fund this unanticipated requirement, it is recommended that \$500,000 be transferred from the General Fund Unallocated Reserve, and \$500,000 be appropriated from unanticipated revenue (the School District negotiated an agreement with the City to share the City's new 800 MGz radio system for which they would pay the City \$755,000 over five years — a lump sum payment of \$644,00 to be made this fiscal year); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer an amount not to exceed \$500,000 from the

Unallocated Reserve Fund 100, Department 605, Organization 100, Object Account 4903, to the Police Department General Fund [110], for the funding of additional patrol officers on an overtime basis.
