RESOLUTION NUMBER R- 278966

ADOPTED ON NOV 12 1991

WHEREAS, The City of San Diego and Greater San Diego Chamber of Commerce have established a community task force to plan a tribute to Theodore (Dr. Seuss) Geisel; and

WHEREAS, the task force has selected November 17 to celebrate the life and works of Theodore (Dr. Seuss) Geisel during a formal tribute at the Balboa Park Organ Pavilion and with ongoing activities throughout the Park; and

WHEREAS, to pay for the expenses of Sunday in the Park with Seuss, funds need to be raised, a budget needs to be approved, and the City Manager may need to execute contracts for and on behalf of The City of San Diego, provided that limitations on expenditures be restricted to the amount of money received as donations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the provisions of Council Policy 100-2, are hereby waived to allow or the receipt of donations for Sunday in the Park with Seuss on November 17, 1991.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to establish a special fund to record all revenues and expenditures of the November 17 Sunday in the Park with Seuss celebrations and thereafter deposit any excess donations in the General Fund.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute all contracts necessary regarding this

celebration, said contracts to be funded to the extent of monies donated and received by the Auditor and Comptroller.

BE IT FURTHER RESOLVED, that the City Council hereby approves the proposed budget for Sunday in the Park with Seuss, attached hereto as Attachment A.
