RESOLUTION DECLARING THE RESULTS OF THE
GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF
SAN DIEGO ON TUESDAY, NOVEMBER 5, 1991.

WHEREAS, a general municipal election was held in The City of San Diego, on Tuesday, November 5, 1991, pursuant to the provisions of Ordinance No. O-17666 (New Series) (adopted on July 22, 1991), for the purpose of electing candidates; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the general municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

The whole number of votes cast in the City was 27,641.
