BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Erick L. Ricci, Registered Civil Engineer, entitled "Las Casitas La Jolla being a subdivision of Lots 8, 9, and 10 of St. Clair's Addition in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2529 filed in the office of the County Recorder of San Diego County on November 22, 1948," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of San Diego the building restricted easements over, upon, or across all of Lot 13 and those portions of Lots 4, 5, 10, 11, and 12 as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said subdivision map, together with the building restricted easements, all as granted and shown on this map within this

subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
