ADOPTED ON NOV 25 1991

WHEREAS, Mr. Ralph Pesquiera, a San Diego Police Department, Level III Reserve Officer, is willing to donate, and the San Diego Police Department desires to accept, a flight simulator in good working condition for use by the San Diego Police Department's Air Support Unit; and

WHEREAS, the eight (8) pilots who fly for the Air Support Unit are required by Federal Aviation Administration (F.A.A.) regulations to log twelve (12) hours of instrument time per year per pilot, six (6) hours of which can be logged in a flight simulator; and

WHEREAS, acceptance of the proposed donation would result in annual savings of about three thousand, five hundred twenty-six dollars (\$3,526.00); and

WHEREAS, the flight simulator is valued at eleven thousand dollars (\$11,000.00) and yearly maintenance costs are not expected to exceed five hundred dollars (\$500.00); NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to accept a donation of a flight simulator valued at eleven thousand dollars (\$11,000.00) from Mr. Ralph Pesquiera for use by the San Diego Police Department Air Support Unit.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the Council, for and on behalf of the City, publicly expresses the gratitude of the citizens of San Diego for this act of civic generosity.
