

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Memorandum of Understanding with the California Department of Commerce regarding The City of San Diego's intent to implement the San Ysidro/Otay Mesa Enterprise Zone, under the terms and conditions set forth in the Memorandum of Understanding on file in the office of the City Clerk as Document No. RR- 279019 - 1

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with SAN DIEGO CONSORTIUM AND PRIVATE INDUSTRY COUNCIL for the Consortium to provide a job referral service to operate in the Enterprise Zone January 1, 1992, through June 30, 1992, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 279019 - 2

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$18,500 for January 1, 1992, through June 30, 1992, and that the expenditure of an amount not to exceed \$37,000 per fiscal year thereafter is hereby authorized, subject to a yearly appropriation by the City Council of funds for the operation of the San Ysidro/Otay Mesa Enterprise Zone.
