RESOLUTION NUMBER R- 279051

ADOPTED ON NOV 26 1991

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on September 19, 1991, for the purpose of considering two amendments to, and the validation of a land use designation of, the Otay Mesa-Nestor Community Plan; and

WHEREAS, the City of San Diego Police and Park and Recreation Departments requested amendments to the community plan for the purpose of changing the land use designation of a 3.3-acre site, located at the southwest corner of Coronado Avenue and 27th Street, from Low Density Residential to Police Station; changing the land use designation of a 9.1-acre site, located on the south side of Grove Avenue between 25th and 27th Streets, from Low Medium Density Residential to Open Space and Parks, to allow the creation of a future park site; and the Planning Department requested validation of the Low Medium Density Residential land use designation of a 4.9-acre site, located on the east side of 27th Street, north of Southwest Junior High School; and


WHEREAS, City Council Policy 600-7 provides that public hearings to consider revisions to the Progress Guide and General Plan for The City of San Diego may be scheduled concurrently with the public hearings on proposed community plans in order to retain consistency between said plans and the Planning Commission has held such concurrent public hearings to consider the Police Station site; and

WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby adopts the amendments to the Otay Mesa-Nestor Community Plan; the amendment to the Police Station site to become effective upon City Council adoption of the General Plan amendment.

BE IT FURTHER RESOLVED, that the Council of The City of San Diego will adopt an amendment to the Progress Guide and General Plan for The City of San Diego to incorporate the above amended plan at the next omnibus General Plan amendment hearing.
