BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT NORTH TORREY PINES ROAD AND TORREY PINES SCENIC DRIVE.

BE IT FURTHER RESOLVED, that the expenditure of \$121,300.00 from CIP 68-010.0, CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC

SIGNALS, Proposition "A", Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in CIP 68-010.0.
