WHEREAS, on November 6, 1991, the Rules Committee reviewed the Department of Legislative Services (DLS) Report No. 91-49, dated October 23, 1991, regarding proposed legislation for sponsorship by The City of San Diego; and

WHEREAS, the Rules Committee approved, as a consent item, the 1992 Legislative Sponsorship Program, as set forth in DDS Report No. 91-49, which contained three proposals for sponsorship, including cost recovery of the City's costs in impounding vehicles, modification of expenditure constraints on strong motion instrumentation program funds (seismic safety fees) retained by the City, and modification of limit on charge for returned checks; NOW, THEREFORE,
