WHEREAS, C.I.P. Project No. 33-078.0 provides for a six-year phased program to construct additional restroom facilities for both male and female firefighters; and

WHEREAS, there are four intermediate stations (8-10 personnel) and 14 residential stations (4-6 personnel) remaining where additional restrooms are needed to maintain privacy for both male and female firefighters; and


WHEREAS, both the California Administrative Code (Title 8) and the Uniform Building Code (Chapter 7) require that separate facilities be provided for males and females when the number of employees exceeds four; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer an amount not to exceed \$100,000 from C.I.P. Fund No. 90245.0 Capital Outlay (other) Unallocated Reserve Fund to C.I.P. Fund No. 33-078.0, for restroom additions to selected Fire stations.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,00 from C.I.P. Fund No. 33-078.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
