APPROVING MAP OF LA JOLLA ALTA
P.R.D. UNIT NO. 14.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "LA JOLLA ALTA P.R.D. UNIT NO. 14 being a subdivision of a portion of Pueblo Lot 1781 of the Pueblo lands of San Diego, according to map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36, and Lots 1 to 32, inclusive, in Block 1 in Sea View Heights, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1125, filed in the office of the County Recorder of San Diego County, March 16, 1908, together with the unnamed alley in said Block 1 as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of

ingress and egress of emergency vehicles and for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easements over, upon, or across Lots 123, 124, 132 and the unnamed alley, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements for private street purposes over, under, upon and across Lots 125, 126, 127 and 128, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, together with the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of sewer, water and drainage facilities, the open space easements, and the private street easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
