NAME(S): Joseph M. Beck and Stan M. Fein
DEPARTMENT: Water Utilities/Metro
AMOUNT: \$250.00 (shared equally)
SUGGESTION: Mr. Beck was a Plant Technician II and Mr. Fein was a Plant Technician Supervisor at the time of submittal. They suggested eliminating water waste by installing an air compressor for the main air supply source at the Pt. Loma Treatment Plant. This is considered an operational improvement.
