WHEREAS, on May 6, 1991, The City of San Diego entered into a Memorandum of Understanding with the San Diego County Water Authority ("CWA") to participate in CWA's Ultra-Low Flush Toilet Rebate Program ("Program"); and

WHEREAS, the City wishes to amend said Memorandum of Understanding to increase the number of toilet rebates that will be available through the Program to the City for the contract period ending June 30, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to amend, for and on behalf of said City, the Memorandum of Understanding with CWA for the services needed to continue the Program for approximately 10,000 additional ultralow flush toilets.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to seek funding from the Metropolitan Water District ("MWD") of Southern California for the purpose of continuing the Program.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$950,000 from the Water Utilities Operating Fund 41500, Administrative Services Program, is hereby authorized, solely and exclusively for the purpose of administering the Program for the contract period ending June 30, 1992.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller are hereby authorized to transfer \$500,000 from the Water Utilities Sewer Revenue Fund 41506 to the Water Operating Fund No. 41400, Revenue Account No. 79899, solely and exclusively for the purpose of providing supplemental funds for the above project.
