
RESOLUTION NUMBER R- 279135

BE IT RESOLVED, by the Council of The City of San Diego, that the Fiscal Year 1992 Capital Improvements Program Annual Appropriations Budget, Ordinance No. O-17667 (N.S.), is hereby modified by the addition of CIP 29-780.0, Famosa Slough Enhancement Plan.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Pacific Southwest Biological Services for preparation of the Famosa Slough Enhancement Plan, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279135, together with any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,000 from Coastal Conservancy Fund No. 38023, as received, is hereby authorized, solely and exclusively for the purpose of providing funds for this project.
