

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street easement deeds of CHILDREN'S HOSPITAL - SAN DIEGO, a California corporation, dated January 29, 1991; SAN DIEGO HOSPITAL ASSOCIATION, a California corporation, and CHILDREN'S HOSPITAL AND HEALTH CENTER, a California corporation, dated June 6, 1990; SAN DIEGO HOSPITAL ASSOCIATION, a California public benefit corporation, dated June 26, 1990; SHARP PROPERTIES, a California nonprofit corporation, dated June 26, 1990; SAN DIEGO HOSPITAL ASSOCIATION, a California corporation, and CHILDREN'S HOSPITAL AND HEALTH CENTER, a California corporation, dated June 6 and June 26, 1990; CHILDREN'S HOSPITAL - SAN DIEGO, a California corporation, dated July 24, 1990; THOMAS M. MCMILLAN and DOROTHY K. MCMILLAN, Co-Trustees, and OLIVER MCMILLAN, a California corporation, dated July 26, 1990; and CHILDREN'S HOSPITAL - SAN DIEGO, a California corporation, dated June 6, 1990; all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 279144-1, RR- 279144-2, RR- 279144-3, RR- 279144-4, RR- 279144-5, RR- 279144-6, RR- 279144-7 and RR- 279144-8, granting to said City easements for public street purposes in portions of Pueblo Lots 1199 and 1202, Lot 1 of Map 849, Lot 1 of Map 4757, and Lot 1 of Map 5569, as more particularly described in said deeds, be, and the same is hereby

approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named CHILDREN'S WAY and BIRMINGHAM WAY.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
