WHEREAS, it has been proposed by the Rules Committee that Rule 21 of San Diego Municipal Code section 22.0101 [Permanent Rules of Council] be amended to increase the membership on the Committee on Public Services and Safety [herein "PS&S"] to six members; and

WHEREAS, an ordinance to amend Rule 21 is in the process of legislative enactment; and

WHEREAS, it is necessary to provide, pursuant to Rule 31, a temporary rule to address the issue of composition of the PS&S Committee until such time as the ordinance amending Rule 21 is effective; and

WHEREAS, such temporary rule will contain the same language as the ordinance, thereby permitting operation of the PS&S Committee in the interim period; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code section 22.0101, Rule 31, entitled "Temporary Rules" there is hereby established a temporary Rule 21.1 to read as follows:

There is a Committee on Public Services and Safety composed of six (6) voting members consisting of six (6) Council members
