RESOLUTION NUMBER R- 279163

ADOPTED ON DEC 10 1991

WHEREAS, on June 10, 1991, by Resolutions No. R-278089, the Council of The City of San Diego at a public hearing approved a Transportation Demand Management (TDM) Program for the La Jolla Cancer Research Foundation and the associated amendment to the North City Local Coastal Program Land Use Plan; and

WHEREAS, on September 11, 1991, the California Coastal Commission at a public hearing considered an amendment to the certified Local Coastal Program to modify the North City Land Use Plan (University Community subarea) to approve a TDM Program for the La Jolla Cancer Research Foundation which was adopted by the Council of The City of San Diego by Resolution No. R-278089; and

WHEREAS, the California Coastal Commission certified the amendment request to The City of San Diego Local Coastal Program North City Segment with suggested modifications which if adopted by The City of San Diego would conform with the certified land use plan and be adequate to carry out the provisions of the certified land use plan; and

WHEREAS, the modifications suggested by the California Coastal Commission have been incorporated into the TDM Program for the La Jolla Cancer Research Foundation; and

WHEREAS, the Council of The City of San Diego has considered the incorporation of the suggested modifications into the TDM Program for the La Jolla Cancer Research Foundation; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that it hereby approves the amendment to the North City Local
Coastal Program Land Use Plan which includes incorporation of the
California Coastal Commission's suggested modifications into the
TDM Program for the La Jolla Cancer Research Foundation.
