WHEREAS, The City of San Diego has designated the Gaslamp Quarter Redevelopment Project area as an historic district; and

WHEREAS, The City of Sna Diego has installed certain public improvements in the Gaslamp Quarter Redevelopment Project area; and

WHEREAS, The City of San Diego wishes to see the sidewalk area adjacent to the property located at 528-540 F Street and 802-810 Sixth Avenue improved in a similar fashion to other sidewalk areas located in the Gaslamp Quarter Redevelopment Project area; and

WHEREAS, because of the existence and condition of a basement underneath the sidewalk area at 528-540 F Street and 802-810 Sixth Avenue, a Sidewalk Improvement Agreement is required in order to protect the health, welfare and safety of the citizens of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager, or his designee, is hereby authorized, on behalf of the City, to execute the Sidewalk Improvement Agreement between The City of San Diego, the Redevelopment Agency of The


