ORDINANCE NUMBER 0-17730 (NEW SERIES)

ADOPTED ON JAN 06 1992

BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, a twenty-five year joint use agreement with the San Diego Unified School District for the construction, operation, maintenance and lease of turfed field and recreation facilities at Farb Middle School, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. 00-17730, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER ORDAINED, that the City Auditor & Comptroller is hereby authorized to transfer an amount not to exceed \$53,500 from PSD Fund No. 11340 to CIP 29-403.0, Roadrunner Neighborhood Park - Development, Phase II.

BE IT FURTHER ORDAINED, that the expenditure of an amount not to exceed \$473,500, consisting of \$245,000 from CIP 29-403.0, Roadrunner Neighborhood Park - Development, Phase II, Tierrasanta - FBA Fund No. 79005, and \$228,500 from PSD Fund No. 11340, is hereby authorized, solely and exclusively for the purpose of constructing park facilities in accordance with this agreement and for related project expenses.

BE IT FURTHER ORDAINED, that the San Diego Unified School District is hereby requested to administer contracts for the construction of turf and irrigation improvements at Farb Middle School at a cost not to exceed \$445,000.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
