
BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the San Diego Unified School District for the construction, operation, maintenance and lease of turfed field and recreation facilities at Angier Elementary School, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO- 17736 , together with any further amendments or modifications thereto which do not increase the agreement's scope or cost and which the City Manager may deem necessary from time to time in order to carry out the purposes and intent of this activity and agreement.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
