AN ORDINANCE AMENDING ORDINANCE NO. O-17667 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1991-92 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (1300) TO EXEMPT A NEW ASSISTANT DEPUTY DIRECTOR POSITION FOR THE PLAN REVIEW SERVICES DIVISION IN THE BUILDING INSPECTION DEPARTMENT FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, in the 1992 budget process, the City Council authorized the reclassification of an Structural Engineering Associate position to Assistant Deputy Director in order to implement the reorganization of the Plan Review Services Division of the Building Inspection Department; and

WHEREAS, this reorganization will result in improved functional control of program activity as well as correct an existing overly broad span of control in the Plan Review Services Division; and

WHEREAS, it has been requested that the Assistant Deputy
Director be exempted from the classified service; and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the Classified Service by ordinance upon
first having been reviewed and commented upon by the Civil

Service Commission; and

WHEREAS, a review of the position indicates the nature and duties of said position is consistent with the unclassified criteria set forth in Charter section 117(a)17; and

WHEREAS, it is now requested that said position be exempted from the classified service pursuant to the Charter provisions; and

WHEREAS, the Civil Service Commission reviewed this request on August 1, 1991, and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said reclassification; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission in its memorandum to the City Council, dated September 16, 1991, attached hereto as Attachment A, the Assistant Deputy Director position for the Plan Review Services Division of the Building Inspection Department (1300) is hereby exempted from the classified service and declared to be in the unclassified service.

Section 2. That Ordinance No. O-17667 (NEW SERIES), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1991-92 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the

same is hereby amended by amending Document No. 00-17667-1, as adopted and amended therein, by amending within the personnel authorization schedule for Building Inspection Department (1300) to reflect therein the Assistant Deputy Director position in the Plan Review Service Division as being in the unclassified service.

Section 3. As a schedule of compensation for the above unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 07.3, 07.4, 07.5 and 07.6 of the Table of Classifications and Standard Salary Rates under Managerial Category B, contained in Exhibit C to Ordinance No. 0-17667 (NEW SERIES), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

SUBJECT: EXEMPTION OF ASSISTANT DEPUTY DIRECTOR POSITION

FROM THE CLASSIFIED SERVICE

On August 1, 1991, the Civil Service Commission reviewed a request from the City Manager's Office to exempt a new Assistant Director position in the Plan Review Services Division of the Building Inspection Department from the Classified Service.

Charter Section 117 states that the Unclassified Service shall include "Managerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council."

Upon review of the duties and responsibilities to be performed, the Commission finds that this position meets the criteria of the Charter and supports exemption from the Classified Service. If additional information would be of assistance in your consideration of this matter, staff is available to respond with details as necessary.
