ADOPTED ON FEB 24 1992

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 9,
DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTIONS 59.0102 and 59.0103
RELATING TO SMOKING AT SAN DIEGO JACK MURPHY
STADIUM.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 9, Division 1 of the San Diego Municipal Code be and the same is hereby amended by amending Sections 59.0102 and 59.0103 to read as follows:

SECTION 59.0102 DEFINITIONS

(a) through (l) - NO CHANGE.

(m) "Outside Seating Area" includes all seats in the Stadium for which a ticket was issued and all adjacent aisleways. It does not include enclosed areas adjacent to skybox ticketed seats.

(n) "Press Level Area" includes the inside area of the Stadium reserved for use by a Stadium tenant or lessee which is on the Stadium Level 2A from Sections 26 through 38.

SECTION 59.0103 ACTIVITIES PROHIBITED WITHIN
SAN DIEGO JACK MURPHY STADIUM

(a) through (l) - NO CHANGE.

(m) Smoking is prohibited in the Outside Seating
Area and the Press Level Area of the San Diego Jack
Murphy Stadium.

Section 2. This ordinance shall take effect and be in force
on the thirtieth (30th) day from and after its passage.
