AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 1, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 71.0103 AND BY REPEALING SECTION 71.0161 BOTH RELATING TO TRANSPORTATION DEMAND MANAGEMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VII, Article 1, Division 1 of the San Diego Municipal Code be and the same is hereby amended by amending Section 71.0103 to read as follows:

**§ 71.0103 Phasing**

This Division shall be implemented in phases as follows:


A. Intermediate Employer - Phasing for Intermediate Employers shall be effective three years and six months from the Implementation Date.

B. through D. [No changes.]

Section 2. That Chapter VII, Article 1, Division 1 of the San Diego Municipal Code be and the same is hereby amended by repealing Section 71.0161.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

The ordinance extends the Transportation Demand Implementation for intermediate sized employees one additional year; it also repeals the sunset provisions of the Transportation Demand Ordinance.
