AN ORDINANCE INCORPORATING 32.73 ACRES
LOCATED ON WORLD TRADE DRIVE BETWEEN CAMINO
DEL NORTE AND CONFERENCE WAY, IN THE CARMEL
MOUNTAIN RANCH COMMUNITY PLAN AREA, IN THE
CITY OF SAN DIEGO, CALIFORNIA, FROM M-LI ZONE
TO M-IB ZONE, AS DEFINED BY SAN DIEGO
MUNICIPAL CODE SECTION 101.0435.2, AND
REPEALING ORDINANCE NO. 16281 (NEW SERIES),
ADOPTED SEPTEMBER 10, 1984, OF THE ORDINANCES
OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME
CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a 32.73-acre site, located on World Trade
Drive between Camino del Norte and Conference Way, in the Carmel
Mountain Ranch Community Plan area, in the City of San Diego,
California, within the boundary of the district designated "M-LI"
on Zone Map Drawing No. B-3977, filed in the office of the City
Clerk as Document No. 00-17754 be, and it is hereby incorporated
into M-IB Zone, as such zone is described and defined by San
Diego Municipal Code section 101.0435.2.

Section 2. That Ordinance No. 16281 (New Series), adopted September 10, 1984, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.

BY AMENDING THE PERSONNEL AUTHORIZATION OF THE CITY MANAGER'S OFFICE (040) TO EXEMPT A NEW ASSISTANT TO THE EXECUTIVE DIRECTOR POSITION FOR THE HUMAN RELATIONS COMMISSION (601) FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR. THEREFOR.

This ordinance amends the appropriation ordinance by amending the personnel authorization of the Human Relations Commission (601) to exempt one (1.00) Assistant to the Executive Director position from the classified service and place it in the unclassified service. The ordinance also establishes a salary rate for said position.
