
BE IT ORDAINED, by the Council of The City of San Diego, as follows:

**Section 1.** Section 3 of Ordinance No. 17748 (New Series) is hereby amended to read as follows:

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, however, the provisions of this ordinance shall not be applicable within the Coastal Zone until the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void within the Coastal Zone.

**Section 2.** This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. O-17667 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1991-92 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17667-1, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$523,250 FROM THE EQUIPMENT DIVISION MOTIVE ACQUISITION FUND (33) TO THE GENERAL FUND 100 AND SUBSEQUENTLY TO THE NEWLY CREATED FUND, ENTITLED "AUTOMATED CONTAINER FUND" FOR THE PURPOSE OF FUNDING AN AUTOMATED REFUSE COLLECTION PILOT PROGRAM IN THE CITY OF SAN DIEGO.

This ordinance amends the annual budget by creating a new fund, entitled "Automated Container Fund," and transferring \$523,250 between various funds of The City of San Diego and subsequently to the Automated Container Fund, for the purpose of funding an automated refuse collection pilot program in The City of San Diego.
