follows:


Section 1. That Ordinance Number O-17467 (New Series) be

effective date of Ordinance Number O-17746 (New
Series), amending the Barrio Logan Planned District.

Section 2. This amendment to Ordinance Number O-17467 (New
Series) shall take effect and be in force on the day of its
adoption by the Council of The City of San Diego and shall remain
in effect for one year or until the effective date of Ordinance
Number O-17746 (New Series), amending the Barrio Logan Planned
District.
