BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 9, Division 1, of the San Diego Municipal Code be and the same is hereby amended by Section 59.0102(1), to read as follows:

(1) "Overflow Capacity Event" shall mean any event in the San Diego Jack Murphy Stadium in which attendance is anticipated to be in excess of fifty-five thousand (55,000) people.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
