AN ORDINANCE INCORPORATING 0.44 ACRES LOCATED ON THE NORTHWEST CORNER OF I-15 AND MERCY ROAD, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM A1-10 TO CA ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0428, AND REPEALING ORDINANCE NO. 8782 (NEW SERIES), ADOPTED JANUARY 31, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 0.44 acres, located on the northwest corner of I-15 and Mercy Road, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "A1-10" on Zone Map Drawing No. B-3966, filed in the office of the City Clerk as Document No. 0-17780, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0428.

Section 2. That Ordinance No. 8782 (New Series), adopted January 31, 1963, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
