AN ORDINANCE INCORPORATING THE WILLOW ROAD ELEMENTARY SCHOOL SITE LOCATED AT 226 WILLOW ROAD IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM CO INTO THE R-3000 (EAST PORTION) ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0410, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Willow Road Elementary School site, located at 226 Willow Road in the San Ysidro Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CO" on C-Sheets No. 848 (Pages 1-20), filed in the office of the City Clerk as Document No. \_\_\_\_\_\_\_, be, and it is hereby incorporated into R-3000 (east portion) Zone, as such zone is described and defined by San Diego Municipal Code section 101.0410.

Section 2. That Ordinance No. 10862 (New Series), adopted June 29, 1972, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
