AN ORDINANCE INCORPORATING THE HAMILTON ELEMENTARY SCHOOL SITE LOCATED AT 2807 FAIRMONT AVENUE IN THE MID-CITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM MR-1500 INTO THE R1-40000 ZONE (NORTHEASTERN PORTION ONLY), AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ORDINANCE NO. No. _____, be, and it is hereby incorporated into R1-40000 Zone (northeastern portion only), as such zone is described and defined by San Diego Municipal Code section 101.0407.

Section 2. That Ordinance No. O-16993 (New Series), adopted December 7, 1987, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
