ADOPTED ON JUL 20 1992

AN ORDINANCE INCORPORATING THE ADAMS
ELEMENTARY SCHOOL SITE LOCATED AT 4672 35TH
STREET IN THE MID-CITY COMMUNITY PLAN AREA,
IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM
MR-1500B INTO THE MR-2500 ZONE AS DEFINED BY
SAN DIEGO MUNICIPAL CODE SECTION 103.1505,
AND REPEALING ORDINANCE NO. O-16993 (NEW
SERIES), ADOPTED DECEMBER 7, 1987, OF THE
ORDINANCES OF THE CITY OF SAN DIEGO INsofar
AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That the Adams Elementary School site, located
at 4672 35th Street in the Mid-City Community Plan area, in the
City of San Diego, California, within the boundary of the
district designated "MR-1500B" on C-Sheets No. 848 (Pages 1-20),
filed in the office of the City Clerk as Document No. 00-17788,
be, and it is hereby incorporated into MR-2500 Zone as such zone
is described and defined by San Diego Municipal Code
section 103.1505.


Section 2. That Ordinance No. O-16993 (New Series), adopted
December 7, 1987, of the ordinances of The City of San Diego be
and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage, and no building
permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
