AN ORDINANCE SETTING ASIDE AND DEDICATING ALL THAT PORTION OF LOT 14 OF TIBBETT'S TRACT, A SUBDIVISION OF THE SOUTH HALF OF THE SOUTHWEST QUARTER OF SECTION 27 AND THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 34, ALL IN TOWNSHIP 18 SOUTH, RANGE 2 WEST, SAN BERNARDINO MERIDIAN, (SITE 617-1) IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that portion of Lot 14 of Tibbett's Tract, a subdivision of the South Half of the Southwest Quarter of Section 27 and the North Half of the Northwest Quarter of Section 34, all in Township 18 South, Range 2 West, San Bernardino Meridian, (Site 617-1), which is more particularly described in Exhibit A hereto which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council of The City of San Diego hereby specifically reserves the right to establish underground public service easements through and across the dedicated property so long as the construction and maintenance of the subject easements do not substantially negatively impact the availability of the property for use for park and recreational purposes.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office

of the San Diego County Recorder a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
