ORDINANCE NUMBER O- 17832 (NEW SERIES)

ADOPTED ON SEP 14 1992

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and directed to execute, for and on behalf of the City, a 25 year joint use agreement with the San Diego Unified School District, for the lease, construction, operation and maintenance of landscaping and recreation facilities at the Dailard Elementary School, under terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO- 17832, together with any amendments or modifications thereto which do not increase this project's scope or cost and which the City Manager may deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
