AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,
DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 101.0423 RELATING TO THE
CO ZONE (COMMERCIAL OFFICE).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0423, to read as follows:

SEC. 101.0423 CO ZONE (COMMERCIAL OFFICE)

A. through C. [No change.]

D. PROPERTY DEVELOPMENT REGULATIONS

No building or portion thereof shall be erected, constructed, converted, established, altered, enlarged or used on any premises nor shall any premises be used unless the lot or premises and buildings shall comply with the following regulations and standards:

1. through 3. [No change.]

4. Maximum Floor Area Ratios.


The maximum floor area ratio shall be two, except within the Kearny Mesa Community Plan area, shown in Document No. RR-~~280821-1~~, on file in the office of the City Clerk. In Kearny Mesa, the floor area ratio shall be 0.50.

5. through 8. [No change.]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
