BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0426.1, to read as follows:

SEC. 101.0426.1 CV ZONE (COMMERCIAL VISITOR -- SERVICE)

A. through G. [No change.]

H. MAXIMUM FLOOR AREA RATIOS


The maximum floor area ratio shall be two (2.0), except within the Kearny Mesa Community Plan area, shown in Document No. RR-280821-1, on file in the office of the City Clerk. In Kearny Mesa, the maximum floor area ratio shall be 0.50, however, the portion of the maximum floor area ratio that may be occupied by the uses specified in Section 101.0426.1(B)(2) (the CV Zone) shall not exceed seventy percent (70%) of the maximum floor area ratio.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
