BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0430, to read as follows:

SEC. 101.0430 C-1 ZONE

A. through C. [No change.]

D. PROPERTY DEVELOPMENT REGULATIONS

No building or portion thereof shall be erected, constructed, converted, established, altered, enlarged or used nor shall any premises be used unless the lot or premises and buildings shall comply with the following regulations and standards:

1. through 3. [No change.]

4. Maximum Floor Area Ratios.

The maximum floor area ratio shall be two, except within the Kearny Mesa Community Plan area, shown in Document No. RR-280821-1, on file in the office of the City Clerk. In Kearny Mesa, the maximum floor area ratio shall be 0.50, however, the portion of the maximum floor area ratio that

may be occupied by the uses specified in
Section 101.0430(B)(2) (the C-1 Zone),
Section 101.0428(B)(3) (the CA Zone) and
Section 101.0426(B)(2) (the CN Zone), shall not
exceed seventy percent (70%) of the maximum floor
area ratio.


