may be occupied by the uses specified in Section 101.0432(B)(4) (the C Zone), Section 101.0428(B)(3) (the CA Zone) and Section 101.0426(B)(2) (the CN Zone), shall not exceed seventy percent (70%) of the maximum floor area ratio.
